New Business: But, we should plan on making a decision on re-investing the large amount of money from the CD that matured. Charlie Morton has presented information about investing in a Vanguard Fund instead of a CD. This CD is just over \$10,000. This Vanguard Fund has averaged over 8% a year for many years. 2 other CD's at about \$13,000 are earning .5%. Previously discussion led to concern about changing fiduciary names when officers change. We will have answers by the next meeting, We need to get this money re-invested soon.

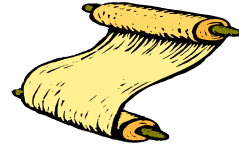
